### Who Should Apply

Internationally educated professionals with postsecondary education in psychology or a related field where a significant component is mental health (e.g., counselling, social work, medicine with specialization in psychiatry, psychiatric nursing, psychotherapy, therapy focusing on mental health, divinity counselling, etc.)

## **Eligibility Requirements**

- Post-secondary education in psychology or a related field, equivalent to 4yrs bachelor's degree where a significant component is mental health (e.g., counselling, social work, medicine with specialization in psychiatry, psychiatric nursing, psychotherapy, therapy focusing on mental health, divinity counselling, etc.)
- Minimum of two years of relevant work experience in psychotherapy, counselling or community mental health outside of Canada
- Language proficiency: CLB 7-7-7-7 for Reading-Listening-Writing-Speaking; or the equivalencies - IELTS 6-6-6-6; CELPIP General 7-7-7-7
- Legal immigration status: Naturalized Canadian Citizen, Permanent Resident, Convention Refugee, and Refugee Claimant with Work Permit, CUAET
- Residence: Ontario



#### Program Components

#### **Employment Stream**

#### 10-12 months

Full-time program, including 4-6 months of supervised placement, mentoring and job search supports.

#### **Employment & Registration Stream** 12-14 months

Full time program, including

- enhanced academic curriculum (over 1,100 hours, including a course series in psychotherapy)
- 6 months of supervised placement
- SEUS seminar (Safe and Effective Use of Self)
- small group clinical supervision
- mentoring and job search supports
